

STEALTHBOND ADHESIVE LIMITED LIFETIME WARRANTY

FEATURE WARRANTED

Subject to the exclusions, conditions and limitations described below, Southeastern Metals Manufacturing Company, Inc. (hereinafter "SEMCO"), hereby warrants that the adhesive bond which is created between: (1) metal roofing panels of a structure on which metal roofing has been installed using the SEMCO StealthBond system; and (2) the StealthConnector (which is a part of the SEMCO StealthBond system), by the application of the StealthBond adhesive (the "StealthBond Adhesive") as the bonding agent between such metal roofing panels and such StealthConnector, will not fail during the life of the metal roofing and the StealthConnector.

For purposes of the foregoing warranty, the life of the metal roofing and the StealthConnector shall mean a period of forty (40) years following installation of the applicable metal roofing and the applicable StealthConnector.

This warranty only applies to the StealthBond Adhesive and is extended only to the original owner of the structure on which metal roofing has been installed using the SEMCO StealthBond system. For transferability options, contact StealthBond 1-844-578-3258.

EXCLUSIONS

This warranty does not cover metal roofing panels or the StealthConnector. In addition, this warranty shall be null and void and of no effect if:

- 1) After installation of a metal roofing system using the SEMCO StealthBond system, any change is made to such metal roofing system;
- 2) During installation of the metal roofing system, the incorrect StealthBond Adhesive bead size has been applied causing insufficient bonding of the metal roofing panels to the StealthConnector; or
- Dirt, oil, residue, or other contamination of the metal roofing panels or the StealthConnector was present during installation and application of the StealthBond Adhesive to the metal roofing panels or the StealthConnector.

CONDITIONS

This warranty shall not be effective unless the following conditions are satisfied:

- 1) The metal roofing panels and the StealthConnector are prepared according to the requirements of the StealthBond Installation Detail Manual Instructions;
- 2) The StealthBond Adhesive is applied according to the requirements of the StealthBond Installation Detail Manual Instructions;
- 3) The installation is subject to normal environmental conditions; and
- 4) The metal roofing was installed and has been maintained in strict compliance with the procedures recommended by SEMCO.

FAILURE TO ADHERE TO THE CONDITIONS SET FORTH ABOVE WILL RENDER THIS LIMITED WARRANTY NULL AND VOID.

LIMITATIONS

EXCEPT AS SET FORTH HEREIN, THERE ARE NO EXPRESS WARRANTIES MADE BY SEMCO WITH RESPECT TO THE STEALTHBOND ADHESIVE. SEMCO DOES NOT MAKE AND THERE ARE NO IMPLIED WARRANTIES BEING MADE WITH RESPECT TO THE STEALTHBOND ADHESIVE, INCLUDING, BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

This warranty gives you the specific legal rights, and you may also have other rights, which vary, by state. The terms of, and remedies available under, this warranty can only be modified or extended if expressly authorized, in writing, by an authorized representative of SEMCO.

MAKING CLAIMS

To file a claim under this warranty, you must contact SEMCO, within fifteen (15) calendar days of the discovery of the failure of the adhesive bond created by use of the StealthBond Adhesive. If the adhesive bond created by use of the StealthBond Adhesive fails, send written notice to SEMCO at the following address:

The terms, conditions and obligations created by this warranty shall be governed by the laws of the state of Florida and any claims arising from this warranty shall be controlled by Florida law and shall be brought in the Superior Court of Duval County, Jacksonville, Florida, said Court being the exclusive and sole jurisdiction and venue to hear any such claim or claims.

REMEDIES

StealthBond, at its option, may designate a representative to inspect the StealthBond Adhesive and/or have the StealthBond Adhesive tested by an independent testing firm. If the inspection or independent testing reveals that the adhesive bond created by the use of the StealthBond Adhesive Adhesive has failed, SEMCO will, at its option:

- 1) Replace the StealthBond Adhesive in the affected area; or
- 2) Refund to the owner of the structure on which the adhesive bond created by using the StealthBond Adhesive has failed, an amount equal to the actual cost to the owner of the StealthBond Adhesive that was used in the affected area.

LIMITATION OF LIABILITY

THE AUTHORIZED INSTALLER ASSUMES ALL RISK OF THE HANDLING AND STORAGE OF THE STEALTHBOND ADHESIVE. EXCEPT FOR THE SPECIFIC REMEDIES SET FORTH HEREIN, SEMCO SHALL HAVE NO LIABILITY FOR ANY DAMAGES, WHETHER DIRECT, INCIDENTAL OR CONSEQUENTIAL (INCLUDING BUT NOT LIMITED TO, DAMAGES FOR LOSS PROFITS), RESULTING FROM THE FAILURE OF THE ADHESIVE BOND CREATED BY USE OF THE STEALTHBOND ADHESIVE OR FROM THE INSTALLATION, USE, PERFORMANCE, MAINTENANCE, REPAIR OR REPLACEMENT OF THE STEALTHBOND ADHESIVE.
